Payroll in Malta



Payroll in Malta involves employers withholding income tax and social security contributions from employees' salaries on a monthly basis, before reporting these amounts to the Commissioner for Revenue Department. Income tax is withheld at a progressive rate.

New Employees in Malta



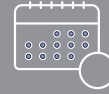
All new employees in Malta must be registered with the Commissioner for Revenue Department and Jobsplus. Employees must be registered within 14 days of the engagement date. All third country nationals must obtain a work permit before starting work in Malta.

Foreign Employees



In addition to the payroll services outlined above, we also assist foreign employees in their relocation to Malta. Our services mainly relate to the registration for Social Security in Malta, registration for residence permit (and in case of non-EU individuals also assistance in obtaining the necessary work permit for Malta) and registration with the Employment authority in Malta.
